For all rooms a 2 nights deposit is required to secure the hotel reservation. Some hotels also require full prepayment, which will be shown at the booking procedure on the platform. The rest of your nights shall be settled directly with the hotel upon check-out. The deposit will be automatically deducted from the hotel invoice. The number of nights originally booked serves as a basis for your hotel invoice. The hotel is entitled to charge the original nights booked in full to the client.

Your payment must reach Kuoni Congress no later than 10 days after booking otherwise your booking will be automatically cancelled.

#### **Cancellation Policies:**

All cancellations and changes are to be addressed to Kuoni Congress in writing.

Cancellations until November 2, 2018: 100% refund, less DKK 200.00 handling fee

Cancellations between November 3, 2018 and December 3, 2018: 1 night cancellation fee will apply

Cancellations received from December 3, 2018: no refund can be made, 100% cancellation fee will apply on the full stay.

No shows: your hotel room will be cancelled after first night of no show and the full amount of your stay will be charged automatically.

Early departure: Guests will be charged in full for checking out prior to the departure date confirmed.

All necessary refunds will be made after the congress.
